6. That Petitioner hereby petitions the Court for the appointment of herself as special and general guardian for the person and estate of the above named minor children.
7. That Petitioner is a resident of _____ County, Oklahoma and are otherwise qualified to act as guardian under the laws of the State of Oklahoma in that the Petitioner is not an incapacitated or partially incapacitated person; a convicted felon; has not declared bankruptcy within the past five (5) years; insolvent; under any financial obligation to the ward; nor subject to a conflict of interest which would preclude or be detrimental to his/her ability to act in the best interest of the ward.
8. That this Court has jurisdiction to determine custody of the above-named minor child(ren) pursuant to Title 43 O.S. Sec. 501 et seq., in that this state is the "home state" of the minor child(ren) as set forth in the Affidavit attached hereto.
9. That so far as is known to the Petitioner, the prospective wards are not represented by counsel, nor are the prospective wards married; and that the prospective wards own an estate of only minimal value; Petitioner is a blood relative of the prospective wards and therefore no bond should be required.
10. That it is necessary for a special guardian to be appointed for the person and estate of the above named minor children to provide for the care of the said minor child.
11. That it is necessary and in the best interest of said child that Petitioner be appointed Guardian for the following reasons:

12. That it is necessary for a general guardian to be appointed for said minor child(ren) to provide for their ongoing care.
13. That the prospective guardian has prepared a plan for the care and treatment of the prospective wards and their estate and the said plan will be filed herein.
14. That it is the fear of Petitioner that if this Court does not take immediate action regarding the physical placement of the minor child(ren) that the child's health, safety, and well-being are in imminent danger.
15. That it is the fear of Petitioner that if this Court does not take immediate action regarding the physical placement of the minor child that it is likely that the Oklahoma Department of Human Services will assume care, custody, and control of the child(ren).

WHEREFORE, your Petitioner prays that he/she be appointed special guardian of the person and estate of the above named minor children upon Petitioners making application for hearing of guardianship with this Court and upon the statutory requirements for notice of such hearing being given according to law.
